The Little Strides program is designed to provide high-quality physical activity breaks to youth in early childhood classrooms. The Little Strides curriculum uses games and activities that focus on developing vital gross motor skills that students need upon entering elementary school.

Running Mates - The Running Mates program utilizes running and physical activity to improve social and emotional well-being of young people in middle school and high school. The Summer Strides season of Running Mates brings youth and community members together in a safe and healthy environment to develop their physical and mental health during the summer months.
